

The Capital Grille Reservation Rescue

Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: The Capital Grille Reservation Rescue (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Sponsor ("Sponsor"), Merkle Inc. and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules. Sponsor's decisions are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. Sponsor: Darden Corporation, 1000 Darden Center Drive, Orlando, FL 32837.

3. Timing: The Sweepstakes begins on January 22, 2026 at 12:00 a.m. Eastern Time ("ET") and ends on February 6, 2026 at 11:59 p.m. (the "Promotion Period"). Sponsor's servers are the official time-keeping devices for the Sweepstakes.

4. How to Enter: During the Promotion Period, visit <https://www.thecapitalgrille.com/reservation-rescue> ("Promotion Site") and follow the links and instructions to accurately complete and submit the registration form, including your first and last name (initials are not sufficient), email address, birthdate, phone number, select from the drop down The Capital Grille restaurant location where you would like to enter to win a reservation on February 14, 2026 at 7:00 p.m. local time and agree to these Official Rules. You will receive one (1) entry into the Sweepstakes. For a full list of participating The Capital Grille restaurants (each, a "Participating Restaurant") see Appendix A, attached.

Limit: You may receive one (1) entry during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than one (1) entry by using multiple/different email addresses, identities, registrations and logins or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and may result in disqualification. In the event of a dispute as to the identity of an entrant, Sponsor will rely on the information submitted by the entrant to register for this Sweepstakes. If any additional information provided by entrant is inconsistent with the information provided at registration for this Sweepstakes, Sponsor may disqualify such entrant and such disqualification may result in the forfeiture of any prizes won. Sponsor, in its discretion, may require additional documentation from entrant to show proof of entrant's identity.

5. Prize Drawings and Winner Requirements: Sponsor's decisions as to the selection of the potential winners are final and binding. Sponsor will randomly select one (1) potential Sweepstakes winner from all eligible entries received during the Promotion Period for each Participating Restaurant on or around February 9, 2026. Potential winners will be notified they are the potential winner of a prize as outlined in Section 6 below by a reservation confirmation email from the OpenTable platform and by email from Sponsor. On February 11 or February 12, 2026, potential winners will also receive a telephone call from The Capital Grille confirming their reservation.

If a potential winner declines the reservation, fails to appear at the designated Participating Restaurant within thirty (30) minutes of their reservation time or the prize is otherwise undeliverable, the potential winner forfeits the prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason or forfeits the prize, Sponsor may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries for the specified Participating Restaurant, time permitting.

6. Prizes, Approximate Retail Value ("ARV"), and Odds of Winning:

- A. Prizes: Seventy-Three (73) Grand Prizes (one (1) awarded per each Participating Restaurant):** One (1) reservation for two (2) (to be used by winner and one (1) guest) on February 14, 2026 at 7:00 p.m. local time at the Participating Restaurant selected by winner upon registration for this Sweepstakes and one (1) \$150 The Capital Grille gift card to use towards the dinner. **Prize must be claimed on February 14, 2026 by utilizing the applicable reservation at the specified Participating Restaurant or winner will be deemed to have forfeited the prize. Reservations will be held for thirty (30) minutes only; potential winners who do not arrive at their reservation within thirty (30) minutes of the reservation time will be deemed to have forfeited the prize.** Gift card will be personally delivered to winner during dinner at the applicable Participating Restaurant on February 14, 2026. Gift card terms and conditions apply. ARV: \$150.
- B. Total ARV:** The total ARV of all available prizes in Florida is \$1,650. The total ARV of all available prizes in New York is \$450.
- C. Odds of Winning:** The odds of winning a prize depend on the total number of eligible entries received for the applicable Participating Restaurant during the Promotion Period.

Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winners are responsible for all taxes and fees associated with prize receipt and/or use. ARVs are determined as of the time these Official Rules were published and the value of a prize may fluctuate. A winner is not entitled to any difference between the ARV and the actual value of the prize at the time the prize is awarded. Where applicable, prize style, size, table selection and all other details will be determined by Sponsor in its sole discretion. All other costs and expenses associated with acceptance of the prize that are not expressly set forth herein shall be solely the winner's responsibility. Prizes are provided "as is" without warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose or non-infringement. Each prize will be fulfilled at the applicable Participating Restaurant on February 14, 2026. Limit of one (1) prize per household.

7. Release: By receipt of any prize, winners agree to release and hold harmless Sponsor, Merkle Inc. and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from any and all actions, claims, injury, loss or damage arising in any manner, directly or indirectly, from participation in this Sweepstakes and/or acceptance, use, inability to use, misuse or redemption of a prize (including any injury or harm related thereto).

8. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance and may modify the prizes offered herein. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be

tampering with the entry process or the operation of the Sweepstakes, including but not limited to submitting fraudulent entries, or to be acting in violation of the Official Rules of this or any other promotion offered by Sponsor in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. In the event there is a discrepancy or inconsistency between any other statements contained in any Sweepstakes-related materials and the Official Rules as posted on the Promotion Site, the Official Rules as posted on the Promotion Site shall prevail, govern, and control.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Michigan without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Michigan.

Severability: If the application of any provision of these Official Rules to any particular facts or circumstances shall for any reason be held to be invalid, illegal or unenforceable by a court, arbitration panel or other tribunal of competent jurisdiction, then (a) the validity, legality and enforceability of such provision as applied to any other particular facts or circumstances, and the other provisions of these Official Rules, shall not in any way be affected or impaired thereby; and (b) such provision shall be enforced to the maximum extent possible. In addition, if any provision contained in these Official Rules shall for any reason be held to be excessively broad as to duration, geographical scope, activity or subject, it shall be construed by limiting and reducing it, so as to be enforceable to the extent compatible with applicable law.
